<sup>1</sup> FY budgets are based on the assumption that current funding levels will remain the same. Staff will continue to seek additional funding sources.

<sup>2</sup> When the Board approved FY 2021/2022 and FY 2022/2023 in May 2021, it was assumed that SoCalGas funding for Program Years 2022 and 2023 would remain the same as 2021 funding. Funding ceased in December 2021 therefore, the budget for LGP was quite different than actual.

<sup>3</sup> Funding total is \$2,500,000 for three years, grant terms June 2024.

## Comparative Analysis FY 2023/2024

Since staff previously presented the FY 2021/2022 & 2022/2023 General and Administrative Budget before the Board on May 20, 2021, the following has occurred:

- Due to discontinued funding from SoCalGas ending December 2021, the Local Government Partnerships that once consisted of both Southern California Edison and SoCalGas concluded.
- CalEPA Grant funding for the Ventura County Green Business Program (VCGB) will continue through December 2023. Continued state funding for 2024 is unknown at this time.
- Due to obstacles and delays with purchasing equipment, EV 2.0 expenses will increase dramatically from FY 2022/2023 (\$365,407) to FY 2023/2024 (\$1,173,007) resulting in an approximated increase in the overall budget for VCREA of 256 percent.
- Staff will continue efforts to pursue other funding sources that align with our mission and goals and will come back to the Board when other funding sources are secured.

# Power Your Future Scholarship

---

## ELIGIBILITY

- Must be a California State Certified General Electrician
- Must work primarily in the tri-county region (San Luis Obispo County, Santa Barbara County, Ventura County)
- Must have work experience in a tri-county region AB 1550 low-income or disadvantaged community

Electricians can expect to be accepted into the program if they meet all scholarship requirements.

Eligible applicants pay for the course up front and are then reimbursed by VCREA once they provide proof of completing the course and passing the EVITP exam.

- 10 approved applicants from 6 companies.

# VCREA Program Update

## Electrified Transportation Updates

### Drive Electric Earth Day

In April, VCREA participated in three highly attended community Earth Day celebrations: Thousand Oaks' Arbor Earth Day on April 15<sup>th</sup>; EVs at Oxnard's Earth Day Farmer's Market on April 20<sup>th</sup>; and EV's at Fillmore's Earth Day on April 22<sup>nd</sup>.

At each event, VCREA staff engaged visitors with a combination of interactive booths, static electric vehicle (EV) displays, and EV painting stations while providing comprehensive EV information, brochures, and virtual EV ride and drives. VCREA partnered with local organizations such as the Mixteco Indigena Community Organizing Project (MICOP) and the County of Ventura Sustainability Division to provide outreach in multiple languages and help visitors learn about EV purchase assistance programs and rebate options. Other partner booths included Clean Power Alliance (CPA), Community Environmental Council (CEC), and Ecology Action's EVs for All program.

Attendees flocked to VCREA's booth, asking questions about EVs and eagerly learning about the many advantages of owning one, including cost savings and environmental benefits. Special highlights included an EV painting experience at the Thousand Oaks event where kids and adults got a chance to express their artistic creativity by painting a Chevy Bolt and a plug-in hybrid EV Chrysler Pacifica with washable paints and at the Oxnard Farmer's Market, verbal EV outreach was provided in English, Spanish, and Mixteco. At all three events, attendees were invited to sign up for EV purchase assistance through Ecology Action's "EV's For Everyone/EV's Para Todos" EV Purchase Guidance Program and were informed about rebate programs that could help finance the purchase of an EV.



### CycleMAYia

VCREA and the County of Ventura are celebrating National Bike Month with CycleMAYnia. Both agencies are hosting a mini-expo that is open to the public on Wednesday, May 31<sup>st</sup> from 10:00 am through 2:00 pm at the Ventura County Government Center Hall of Administration. The public is invited to visit bike shop and County agency booths, grab a bite to eat from local food vendors, attend a Bike Safety and Bike Tune-Up workshop, and take a test ride on an e-bike.



## EV Workforce Development

On February 9<sup>th</sup>, VCREA and Central Coast Clean Cities Coalition (C5) hosted the *Power Your Future* webinar announcing a scholarship opportunity for all state-certified general electricians in the Central Coast tri-county region. The "Power Your Future" Scholarship pays for electricians EV infrastructure training and Electric Vehicle Infrastructure Training Program (EVITP) certification. Thus far, three electricians have finished the course and two electricians have passed the EVITP certification exam. To learn more about EVITP and this scholarship opportunity, click [here](#).



Future EV-related Workforce Development Trainings will include a Dealership Training to increase EV sales in the region and an EV safety course titled *Implications & Considerations for Emergency Responders*. The National Alternative Fuels Training Consortium (NAFTC) EV safety course will help firefighters and other emergency responders understand how a response involving these EVs is different than those with an internal combustion engine.

## Regional Collaboration

### Energy Champion Meeting

VCREA is hosting an in-person Energy Champion Meeting on Thursday, May 25<sup>th</sup> from 11 am to 12:30 pm in the Pacific Conference Room at the County of Ventura Government Center. The meeting will be an opportunity for our partners to provide updates on their organization's initiatives and climate-related needs. VCREA staff will present on continuing regional initiatives and there will also be an opportunity to discuss the US Department of Transportation's Charging and Fueling Infrastructure (CFI) Discretionary Grant program and the US Environmental Protection Agency's Climate Pollution Reduction Grant (CPRG) program. Both grants are described in more detail in the Central Coast Grant Opportunities section of the VCREA Program Update.

### Green Business Program

VCREA staff attended the Spring 2023 California Green Business Network Statewide Conference on April 27<sup>th</sup> and 28<sup>th</sup> where they learn about new types of businesses that are being certified throughout the state. Nail salons were highlighted as one of the new businesses and there was a presenter from a nail salon in San Francisco who discussed the process of getting certified. There were also workshops on how to best utilize social media for the Green Business Program, specifically "Reels" on Instagram.

With funding provided by the Sustainable California Libraries Grant program, the Saticoy, Piru, and El Rio libraries are going through the Green Business Certification process. The grant funding is also helping VCREA staff install some energy efficiency and green upgrades at the three libraries including LED lights. Lastly, the Sustainable California Libraries Grant is paying for VCREA staff to present on EV purchase guidance, home weatherization tips, and green business certification as part of the County of Ventura Library's Sustainable Living Practice series.

## Resilient Central Coast Campaign



The bilingual [Resilient Central Coast Campaign](#) showcases the landing pages for twelve Central Coast cities and counties partnering to achieve measurable progress towards reducing greenhouse gas (GHG) emissions from four areas (home energy use, transportation, food choices, and waste). As part of the regional campaign, the Climate Resilient Ventura County (VC) page launched earlier this Spring. During

## Central Coast Grant Opportunities

VCREA, in partnership with Counties of Ventura and Santa Barbara, Ventura County Community Foundation, Santa Barbara Regional Climate Collaborative, Central Coast Climate Justice Network, Legacy Works Group, and Community Environmental Council, submitted a grant application for a [Governor's Office of Planning and Research \(OPR\) ICARP Adaptation Planning Grant](#) to develop a Central Coast Heat Action Plan as an overarching adaptation vision for extreme heat resilience through Ventura and Santa Barbara Counties and accompanied equitable action plan evaluation tool(s). If funding is awarded, this plan will enable existing regional community stakeholders to be ready to receive resources and funding to implement projects that adapt vulnerable neighborhoods to become resilient to extreme heat events.

VCREA, in partnership with the City of Thousand Oaks, is working with our city partners to apply for the [CFI Discretionary Grant Program's](#) Community Charging and Fueling Grant (Community Program). The [CFI Grant Program](#) is a new competitive grant program created by President Biden's Bipartisan Infrastructure Law to strategically deploy EV charging infrastructure and other alternative fueling infrastructure projects in urban and rural communities in publicly accessible locations, including downtown areas and local neighborhoods, particularly in underserved and disadvantaged communities. VCREA and the City of Thousand Oaks are actively collecting EV-related project information and community outreach proposals

as well as priority locations for charging infrastructure from our Energy Champions to include in the grant proposal. The grant application is due on June 13<sup>th</sup>.

VCREA, in partnership with the ten cities in our region, is developing an application to the [CPRG Grant program](#). This new grant program was created as part of the Inflation Reduction Act to provide funding to states, local governments, tribes, and territories to develop and implement plans for reducing greenhouse gas emissions and other harmful air pollution. The CPRG program is designed to provide support and funding to update existing climate, energy, or sustainability plans, or to develop new plans. This grant application is due on May 31<sup>st</sup>.

### **Letters of Support (attached)**

VCREA submitted a letter of support to the Members of the California Senate and Assembly Budget Committees on behalf of the Ventura County Green Business Program to request a \$3 million appropriation for both fiscal year (FY) 2023-24 and FY 2024-25 for the statewide California Green Business Program. The California Green Business Program, which is implemented locally by counties, cities, and other local government agencies, is currently funded by the California Environmental Protection Agency.

VCREA, along with 45 agencies and organizations working to advance climate action and resilience-building efforts across the state, submitted a letter of support to California State leaders urging them to fully restore the proposed cuts to vital climate and energy programs in the Governor's January Proposed Budget.

VCREA submitted a letter of support to the Integrated Climate Adaptation and Resiliency Program (ICARP) for Community Environmental Council's application to launch the Central Coast Heat Action Coalition resulting in the development of an overarching adaptation plan for extreme heat resilience in Ventura, Santa Barbara, and San Luis Obispo counties.

VCREA submitted a letter of support to the Federal Transit Administration's FY 2023 Areas of Persistent Poverty Grant Program Notice of Funding Opportunity for Gold Coast Transit District's Scheduling and Dispatching Modernization Project.

VCREA submitted a letter of support to California Assembly Committee on Appropriations and the California Assembly Committee on Water, Parks, and Wildlife for AB 953 (Connolly and Hart), which will develop a statewide voluntary vessel speed reduction and sustainable shipping program for the California coast to reduce air pollution, the risk of fatal vessel strikes on whales, and harmful underwater acoustic impacts.
